



## WH Rescission Proposal to Be Smaller Than Originally Expected

The Trump Administration has decided to request no more than \$25 billion in its forthcoming rescission package, according to Rep. Tom Cole (R-Okla.), chairman of the House Appropriations Labor/HHS Subcommittee. This is less than the amount originally anticipated since package of cuts to fall in the range of \$30 to \$60 billion. While some of the funding will be pulled from the most recent omnibus spending deal, the White House is also expected to rescind unspent funding from prior years. The package could be just the first of several claw backs to come from the Trump administration this year and is expected to be released after lawmakers return from a week-long recess on May 7. Office of Management and Budget (OMB) Director Mick Mulvaney hopes the House will vote on the proposal before July.

### VA Nominee Withdraws from Consideration

Navy Rear Admiral Ronny Jackson has withdrawn his name from consideration as the President’s pick to lead the Department of Veterans Affairs (VA). The decision followed a report from the New York Times on allegations that Jackson allowed drugs to be overprescribed, drank excessively, and oversaw a hostile work environment. Jackson maintains that the allegations are “false and fabricated.” The Senate Veterans’ Affairs Committee had indefinitely postponed his confirmation hearing after concerns were raised about his background and qualifications. The White House defended their nominee, citing his record of bipartisan service and “strong, decisive leadership,” and left the decision to withdraw the nomination to Jackson. President Trump has stated that he has a new nominee in mind with more political experience, but has declined to say who it is. Former House Veterans Affairs Committee Chairman Jeff Miller’s name has been floated; Miller helped design the VA Choice program during

his time in Congress. President and CEO of Ascension Anthony Tersigni is also among those being considered to lead the department. Dr. Jackson will not return to his role as the president's personal physician. Rather, Dr. Sean Conley, a naval officer, will continue to serve as the White House physician after he took over the position last month.

### ***GAO Releases Report on Synthetic Opioids***

The Government Accountability Office has released a new **report** recommending that federal agencies strengthen their efforts to assess and thwart the distribution of synthetic opioids. The report acknowledges that many departments have ongoing efforts to seize illicit synthetic opioids but do not monitor the outcomes of their actions. According to the report, "only one of the five strategies we reviewed included outcome, or results-oriented measures – largely due to agency perceptions that designing such measures posed challenges." The GAO also examined obstacles to overdose data sharing between federal law enforcement agencies and the public health sector. The report states "embarking on a concerted effort, led by the Office of National Drug Control Policy (ONDCP), to examine and address data related concerns will enhance agencies' efforts to continue to understand and respond to the opioid epidemic." The agency issued six recommendations to Customs and Border Protection (CBP), ONDCP, the Department of Justice (DOJ), and the Drug Enforcement Administration (DEA) aimed at combating the rise of synthetic opioids.

### ***HHS Releases Cures Parity Action Plan***

The U.S. Department of Health and Human Services (HHS) has released the **Mental Health and Substance Use Disorder Parity Action Plan**. The plan was required under statute by the 21st Century Cures Act, and outlines recent and forthcoming actions from HHS, the Department of Labor, and the Department of Treasury to implement the Paul Wellstone and Pete Domenici Mental Health Parity and Addiction Equity Act of 2008 (MHPAEA) and is based on feedback received from stakeholders last year. MHPAEA requires that employment-based group health plans and health insurance issuers that choose to provide mental health and substance use disorder benefits must cover it in parity with medical and surgical benefits. The Action Plan aligns with HHS' five-pillar strategy to address the opioid crisis.

### ***HELP Advances Opioid Crisis Package***

The Senate Health, Education, Labor, and Pensions (HELP) Committee unanimously advanced S. 2680, the Opioid Crisis Response Act of 2018 last week. The legislation includes more than 40 bipartisan proposals from 38 different senators. The bill reauthorizes a grant program to increase access to addiction treatment created by the 21st Century Cures Act for an additional three years and makes changes to the funding formula to prioritize states most affected by the opioid epidemic. The legislation also creates new grants for the establishment of comprehensive opioid recovery centers to provide medication-assisted treatment (MAT) and related services and will allow the National Institutes of Health (NIH) additional flexibility in conducting opioid-related research. The bill will also make it easier for providers to prescribe smaller packs of painkillers for limited duration and includes provisions to increase detection of illegal drugs at the border. During the markup, Chairman Lamar Alexander (R-Tenn.) stated his hopes that the bill will be considered by the full Senate this summer.

### ***E&C Subcommittee Considers 60+ Opioid Bills***

The House Energy and Commerce Health Subcommittee has advanced 57 bills focused on combating the opioid crisis. Not all measures were passed with bipartisan support, and Democratic members voiced concern that the committee was moving too quickly on too many bills that had not yet been fully vetted by staff, stakeholders, and the appropriate agencies. Republican leadership responded that many of the bills were left in discussion draft form in order to continue work on getting the technical details correct. Thirty-five bills were passed by voice vote, 13 were passed en bloc, and nine bills passed by individual roll call vote. Subcommittee Chairman Michael Burgess (R-Texas) adjourned the hearing without considering six bills that were originally included in the markup notice but stated his intention to continue working on the legislation. Full committee markup of the bills is expected to take place within the next several weeks. Chairman Greg Walden (R-Ore.) has repeatedly stated that he hopes the House will take up the opioid legislation by Memorial Day weekend. During the markup, the subcommittee also advanced legislation to reauthorize the Animal Drug User Fee Act (ADUFA) and the Animal Generic Drug User Fee Act (AGDUFA).

### ***Opioid Declaration Renewed***

The Trump Administration has renewed the public health emergency declaration for the opioid crisis, effective April 24. The opioid epidemic was first declared a national public health emergency in October. The 90-day designation was renewed again in January. The declaration gives federal agencies the authority to more quickly hire treatment specialists and reallocate resources to respond to the crisis.

### ***Trump Formally Nominates Drug Czar***

The White House has officially nominated Jim Carroll to serve as director of the Office of National Drug Control Policy (ONDCP). Carroll was picked as the acting director and deputy director of the office in February. Carroll is a career lawyer who also served in the George W. Bush administration.

### ***Carter Introduces 340B Transparency Bill***

Rep. Buddy Carter (R-Ga.) has introduced legislation that would require hospitals participating in the 340B drug discount program to report on how much outpatient care they provide to low-income patients. The 340B Optimization Act (H.R. 5598) is one of several bills introduced this Congress to increase transparency in the drug discount program. 340B covers outpatient drugs but only counts inpatient care for participant eligibility. Rep. Carter stated that the Energy and Commerce Committee plans to address the issue of 340B reform this year.

### ***HELP to Consider Maternal Mortality Measure Next Month***

The Senate Health, Education, Labor, and Pensions (HELP) Committee plans to vote on a bipartisan bill next month to address the nation's increasing maternal mortality rate, according to Ranking Member Patty Murray (D-Wash.). The Committee will mark up the Maternal Health Accountability Act (S. 1112) sponsored by Sens. Shelley Moore Capito (R-W. Va.) and Heidi Heitkamp (D-N.D.) to support state efforts to track and investigate pregnancy-related deaths and prevent future deaths from occurring. It is not clear when the Energy and Commerce Committee will consider the House version of the bill (H.R. 1318), sponsored by Rep. Jaime Herrera Beutler (R-Wash.).

### ***Marijuana Research Gains Support of Judiciary Chairman***

House Judiciary Committee Chairman Bob Goodlatte (R-Va.) has signed on to bipartisan legislation to ease restrictions around medical marijuana research. The Medical Cannabis Research Act (H.R. 5634) is sponsored by Rep. Matt Gaetz (R-Fla.), who has reportedly received assurances from the Chairman that a committee vote will be held on the bill this year. House Speaker Paul Ryan (R-Wis.) has not yet committed to scheduling a floor vote. The Drug Enforcement Administration (DEA) has signaled that it is willing to expand efforts to research medicinal uses of the drug, however, despite the fact that Attorney General Jeff Sessions is a strong critic of marijuana use.

### ***Meehan Announces Retirement, Effective Immediately***

Rep. Patrick Meehan (R-Pa.) announced on Friday that he would resign from Congress, effective immediately. Meehan had already announced that he planned to retire from Congress following allegations of sexual misconduct. He stated that he did not want to put staff or taxpayers through the rigors of an Ethics Committee investigation. Meehan was a former member of the Ethics Committee. Under state law, the Pennsylvania Governor will call a special election no earlier than 60 days from the date of Meehan's resignation. Candidates will be chosen by the political parties during a nominating convention.

### ***PAHPA Draft Open for Comment***

The Senate Health, Education, Labor, and Pensions (HELP) Committee has released a draft bill to reauthorize federal bioterrorism and pandemic countermeasure programs through fiscal year (FY) 2023. The **Pandemic and All-Hazards Preparedness and Advancing Innovation Act of 2018 discussion draft** was written by Sens. Richard Burr (R-N.C.), Robert Casey (D-Pa.), Lamar Alexander (R-Tenn.), and Patty Murray (D-Wash.). Current authority for the Pandemic and All-Hazards Preparedness Act (PAHPA) expires on September 30, 2018. In addition to reauthorization of funding for the nation's public health preparedness and response framework, the discussion draft considers lessons learned from recent public health emergencies. The committee will accept feedback on the draft to PAHPA2018@help.senate.gov through May 4.

### ***Senators Question Native American Medicaid Work Requirements***

A bipartisan group of senators has **written** to HHS Secretary Alex Azar to express concerns about efforts to institute work requirements for Native Americans covered by the Medicaid program. The administration has rejected the tribes' request to be exempted from new Medicaid work rules being implemented in several states. The tribes cite their status as a separate government. HHS has stated that such an exemption would constitute an illegal racial preference. Ten senators, led by Sens. Tom Udall (D-N.M.) and Lisa Murkowski (R-Alaska), argue that there is longstanding legal precedent recognizing "the unique legal status of Indian tribes and their members under federal law, the U.S. Constitution, treaties, and the federal trust relationship." They request that the administration share further details explaining why Native Americans would be subject to Medicaid work requirements.

### ***House Appropriators Plan Series of Minibuses***

Republican appropriators in the House plan to bring small packages of spending bills to the floor, rather than attempt to move 12 individual appropriations measures or a single omnibus package. According to Reps. David Joyce (R-Ohio), Tom Cole (R-Okla.), and Ken Calvert (R-Calif.), non-controversial measures, like Military Construction-VA, Energy and Water, and Legislative Branch, will be considered first. The House Budget Committee also plans to release and mark up a budget resolution. A draft document was circulated among some committee members last week. The measure balances the budget within 10 years and calls for significant cuts to mandatory programs. Both the House and the Senate have already missed the formal April 15 deadline to agree upon a budget resolution.

### ***GOP Holds Arizona's 8th District in Special Election***

Debbie Lesko (R) won last week's special election against Democrat and emergency physician Hiral Tipirneni to represent Arizona's 8th Congressional District. Although the district was carried by Trump by more than 20 points in 2016, Lesko won by just a six-point margin. Some election experts have argued that this result indicates that Democrats could win significant gains in the November midterm elections. Lesko is a former state senator. She replaces Rep. Trent Franks (R), who resigned in February.
