WH Budget Coming This Friday

The President's fiscal year (FY) 2022 budget proposal is slated to be released on Friday, May 28, according to the Office of Management and Budget (OMB). OMB had previously announced that the budget would be unveiled on May 27. The *Washington Post* has reported that the budget will not include several health care proposals touted by President Joe Biden on the campaign trail, such as a government-run public health insurance option and provisions to lower the cost of prescription drugs. A White House spokesperson confirmed that the budget will not include any major initiatives that have not already been released. The administration is prioritizing its Build Back Better proposal, which contains trillions in spending for infrastructure and social welfare programs.

CMS Nominee Moves Closer to Confirmation

Chiquita Brooks-LaSure, the President's nominee to lead the Centers for Medicare and Medicaid Services (CMS), could see a confirmation vote in the Senate as early as this week. The chamber is scheduled to vote today at 5:30 p.m. on whether to invoke cloture on her nomination, the last procedural vote before a final confirmation vote. Simple majorities are required for both cloture and the final vote. Brooks-LaSure is a former Obama administration health official who helped implement the Affordable Care Act (ACA) while serving as deputy director for policy at the Center for Consumer Information and Insurance Oversight (CCIIO). She also chaired President Joe Biden's health transition team. Earlier in her career, she was a staffer for the House Ways and Means Committee where she helped to draft the ACA while working with HHS Secretary Xavier Becerra, who served on the panel during his time in Congress.

Her nomination has been slowed due to Republican opposition led by Sen. John Cornyn (R-Texas) in protest of the Biden administration's recent decision to revoke a 1115 Medicaid waiver extension for the state of Texas; the waiver was approved in January by the Trump administration. She appears to have enough support for confirmation; Sens. Susan Collins (R-Maine) and Jerry Moran (R-Kan.) previously joined Democrats in supporting her nomination.

Recently Passed Health Care Legislation

The House of Representatives passed the *Fairness in Orphan Drug Exclusivity Act* (H.R.1629) last week. The bill would prevent pharmaceutical manufacturers from extending their patent protections on certain orphan drugs and would limit exclusivity for new versions of older drugs. The bill was passed by a vote of 400-23. The administration has stated that the measure is supported by the President. The Senate cleared the *TRANSPLANT Act* (H.R.941) by voice vote last week. The bill, which was passed by the House in April, would reauthorize the *Stem Cell Therapeutic and Research Act of 2005*. It will now be sent to the President's desk for his signature.

Sanders to Introduce Health Care Workforce Legislation

Sen. Bernie Sanders (I-Vt.) has introduced legislation to address the nation's health care workforce shortages. The <u>Addressing the Shortage of Doctors Act</u> will add 14,000 Medicare-funded graduate medical education (GME) slots over the course of 7 years, reserving half of the new slots for training primary care physicians. It would also increase funding for the National Health Service Corps (NHSC) by \$1 billion per year for 10 years and permanently authorize the Teaching Health Center GME program.

Cures 2.0 Expected to be Released Next Month

The latest draft of the follow-up legislation to the 21st Century Cures Act is expected to be released in early June, according to the bill's authors Reps. Diana DeGette (D-Colo.) and Fred Upton (R-Mich.). The measure will be focused on the delivery of cutting edge treatments and will include the President's proposal for the creation of an Advanced Research Projects Agency for Health (ARPA-H). It will also include provisions on how to improve pandemic preparedness and increase diversity in clinical trials. DeGette and Upton have begun discussions with their Senate colleagues on the measure. They hope to pass Cures 2.0 by the end of the year but have indicated that the bill could be attached to upcoming Food and Drug Administration (FDA) user fee reauthorizations, which expire in September 2022.

Lawmakers Request More Aid for Health Care Coverage

Americans' health insurance premiums, deductibles, and out-of-pocket costs. The lawmakers, led by Sen. Jeanne Shaheen (D-N.H.), argue that such expenses are deterring individuals from obtaining health insurance coverage. "To make historic progress toward covering the uninsured, and to ensure that having coverage truly delivers affordable access to health care and improved financial security, additional federal assistance to reduce cost-sharing expenses is critical," the senators write. They also urge the administration to undertake a new effort to close coverage gaps in states that have not expanded their Medicaid programs.

Oversight Panel Investigates AbbVie Price Hikes, Emergent Vaccine Manufacturing

The House Oversight and Reform Committee has released a new staff report investigating price hikes and patent activity undertaken by pharmaceutical manufacturer AbbVie. The report outlines how the company used its market power and the patent system to increase sales of its rheumatoid arthritis medication Humira in the U.S. while lowering its prices abroad. The analysis is based on internal company documents obtained by the committee. Chair Carolyn Maloney (D-N.Y.), Judiciary Committee Chair Jerrold Nadler (D-N.Y.), and Subcommittee on Antitrust, Commercial, and Administrative Law Chair David Cicilline (D-R.I.) also sent a letter to the Federal Trade Commission (FTC) last week urging the agency to open a formal inquiry into AbbVie's actions to delay competition from biosimilar products.

The committee also released its initial findings from its investigation into vaccine manufacturer Emergent BioSolutions Inc. The report details the company's failure to address deficiencies in its vaccine production following warnings stemming from a series of FDA inspections last year. The warnings suggested that Emergent required "extensive training of personnel" and "strengthening of the quality function," and that it had a deficient virus contamination control strategy. The probe also includes information related to the contract awarded to Emergent by the Trump administration and the company's relationship with former administration official Robert Kadlec.

GAO Releases New Report on COVID-19 in Nursing Homes

A new report from the Government Accountability Office (GAO) reveals that 94% of nursing homes in the U.S. reported multiple COVID-19 outbreaks over the last year. The coronavirus pandemic killed more than 132,000 nursing home residents across the approximately 15,000 nursing homes in the nation. Only 64 facilities reported no outbreaks at all, while 85% of facilities experienced outbreaks that lasted for 5 weeks or more.

Stakeholders Push for Investment in Health Care Infrastructure

A coalition of more than 229 health care stakeholder organizations is <u>urging</u> congressional leadership to include investments in the medical research enterprise as lawmakers consider initiatives to strengthen the nation's infrastructure. The Ad Hoc Group for Medical Research endorses the bipartisan *RISE Act* (H.R. 869/S. 289), which would provide one-time emergency funding for federal research agencies, including \$10 billion for the National Institutes of Health (NIH). The groups also encourage additional support for extramural and intramural research facility upgrades and further investments in high-speed computation, greater data repository capacity, and improved biocontainment capabilities.

AAMC Leads Letter on Increasing GME Residency Slots

The Association of American Medical Colleges (AAMC) spearheaded a letter to congressional leadership last week pushing for the inclusion of support for physician training in upcoming legislative efforts to improve the nation's infrastructure. The letter, which was signed by members of the Graduate Medical Education (GME) Advocacy Coalition, endorses passage of the *Resident Physician Shortage Reduction Act* (S. 834/H.R. 2256) to alleviate the shortage of physicians in the U.S., which is estimated to reach between 54,100 and 139,000 physicians by 2033. The legislation would gradually provide 14,000 new Medicare-supported GME positions targeted at hospitals serving patients in health professional shortage areas, hospitals in states with new medical schools or branch campuses, and hospitals already training over their Medicare caps.
